RE: Notice of Planned Participation in EPA's Effluent Limitation Guidelines (ELG) Permanent Cessation of Coal Combustion by December 31, 2034 Subcategory at Bremo Power Station (VPDES Permit #: VA0004138).

To Mr. Showman:

On behalf of the Bremo Power Station, Dominion Energy Virginia (DEV) submits the attached "Notice of Planned Participation in the EPA's Effluent Limitation Guidelines Permanent Cessation of Coal Combustion by December 31, 2034 Subcategory". This submittal complies with the requirements outlined in EPA's 2024 ELG Final Rule and codified in 40 CFR 423.19(h)(1) and (2).

Background:

On May 9, 2024, the EPA published the Supplemental Effluent Limitation Guidelines and Standards for the Steam Electric Generating Point Source Category Rule (2024 Rule) which, among other changes, created a new subcategory for electric generating units (EGUs) permanently ceasing coal combustion by December 31, 2034. . The 2024 Rule required permitted facilities to submit NOPPs indicating participation in this subcategory no later than December 31, 2025.

DEV's Bremo Power Station (Bremo) is a retired steam electric power generating station located in Bremo Bluff, VA. The station discharges to the James River and Holman Creek in accordance with the Virginia Department of Environmental Quality's (VDEQ) Virginia Pollution Discharge Elimination System (VPDES) permit VA0004138.

The permanent cessation of coal combustion for this facility was achieved in September 2013.



DEV submits the following information pursuant to 40 CFR 423.19(h)(2):

The shutdown of Units 3 and 4 has been approved by VDEQ.

Dear Responsible Official:

The Department of Environmental Quality (DEQ) is joining you in a mutual determination, pursuant to 9 VAC 5-80-1305 A.1.d and 9 VAC 5-20-220 of Virginia's Regulations for the Control and Abatement of Air Pollution, regarding the shutting down of the referenced equipment. The Regulations provide that the DEQ and the owner of a source may make a "mutual determination that a stationary source or emissions unit is shutdown permanently." The Regulations also require that, upon making a final decision that the source is permanently shutdown, the DEQ revoke all applicable permits. This mutual determination must be signed by a "responsible company official."

In execution of this mutual determination of permanent shutdown, Dominion agrees that:

1. A mutual and final determination has been made that the referenced equipment as described below is permanently shutdown.

4. The DEQ will remove the referenced equipment from the air emission inventory and will consider its air pollutant emissions to be zero in any future air quality analysis; and
5. Upon signature of this document by the Department and by Dominion, the referenced equipment shall cease operations. No future operations shall occur until the owner has obtained a permit pursuant to applicable provision of 9 VAC 5 Chapter 80 in the Regulations. Any use of the equipment after execution of this document shall be considered equivalent to construction and operation of a new emissions unit and may subject Dominion to the requirement to obtain a permit pursuant to applicable provision of 9 VAC 5 Chapter 80 in the Regulations.
6. The permanent shutdown of the referenced equipment will become effective upon signature of this document by both parties.
7. The permanent shutdown of the referenced equipment is binding upon Dominion, its successors in interest, designees, and assigns, jointly and severally.
