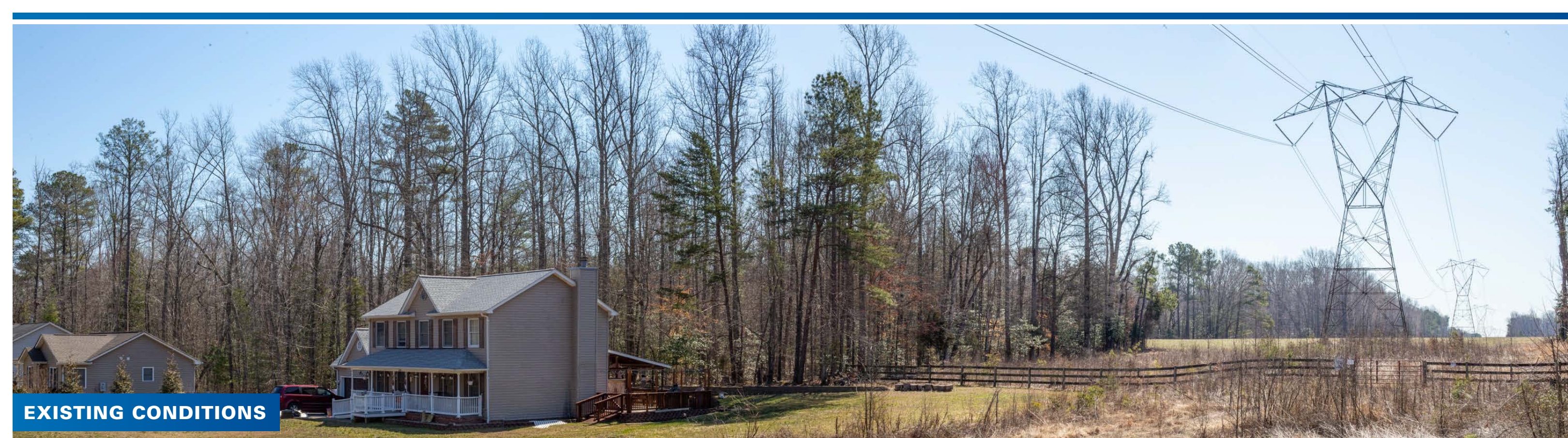

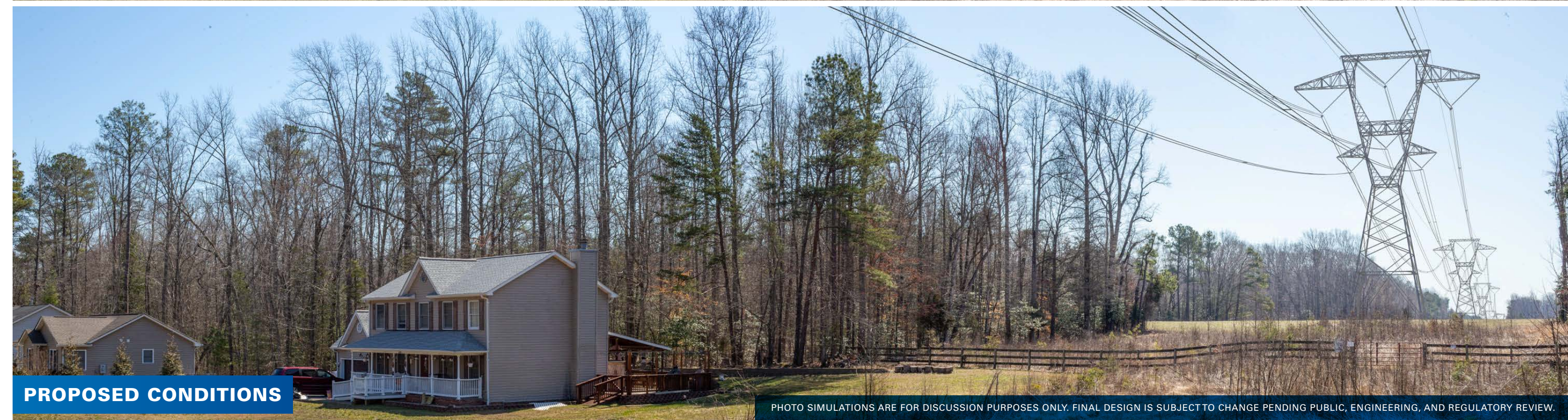
## VIEWPOINT LOCATION MAP
