South Carolina Public Service Commission Schedules Public Hearing to Gather Customer Testimony in Docket No. 2025-325-E

Columbia, South Carolina—The Public Service Commission has scheduled a series of customer public hearings in [Docket No. 2025-325-E](#), which relates to Dominion Energy South Carolina, Inc. (DESC)’s application for authority to adjust and increase its retail electric rates and charges. Three customer public hearing dates in North Charleston, Bluffton, and Aiken will be in-person only, and the Columbia customer public hearing will be in-person or virtual so that DESC customers can testify over the phone. Customers are invited to preregister now to testify at one and only one of these hearings.

According to DESC’s application, the proposed rates and charges represent an overall average increase in retail revenues of 11.47%, or approximately \$322 million. The details of the Company’s calculations are set forth in DESC’s Application and Prefiled Direct Testimony, which can be found [at this link](#).
