Re: Guideline Letter – Incentive Compensation Related to Financial Goals

The Utah Division of Public Utilities ("Division"), Questar Gas Company (called here "Questar Gas" and currently known as Questar Gas Company dba Dominion Energy Utah/Wyoming) and Wexpro Company ("Wexpro") have recently discussed the methods for allocating or charging incentive compensation paid to Wexpro employees to the Operator Service Fee for both the Wexpro I Agreement and the Wexpro II Agreement. This guideline letter serves to memorialize the understanding of the parties and is effective as of the calendar year beginning January 1, 2015.

Under paragraph III-5(b) of the Wexpro Agreement and paragraph III-4(b) of the Wexpro II Agreement, the parties to those agreements agreed that "[b]illing for services will be on a monthly cost-of-service basis and will follow, to the extent applicable and practicable, the methods and practices employed by the Utah and Wyoming Commissions in determining the Company's [initially Mountain Fuel Supply Company, then Questar Gas Company, and currently Questar Gas Company dba Dominion Energy] cost of service prior to the effective date of this Agreement." The undersigned parties recognize and agree that incentive pay related to Wexpro's financial goals will be excluded when calculating the Operator Service Fee.

Adoption of this guideline letter will provide for clear application of excluding these costs. Please indicate your acceptance of this guideline letter by executing this letter below.
