### ABOUT THE PROJECT

At Dominion Energy, we are committed to providing safe, reliable natural gas service at the lowest possible cost. Dominion Energy Ohio is proposing improvements to the Augusta Station facility located in East Township, Carroll County, Ohio. The proposed improvements include the installation of two (2) gas fired compressor units and associated equipment. Upgrades to the facility are required to add capacity to the existing natural gas pipeline system in order to meet growing energy needs for Dominion Energy Ohio customers.

The Augusta Project's added capacity would supply enough natural gas to serve an additional 90,500 households on a single winter day.


#### **ENVIRONMENTAL STEWARDSHIP**
