Open houses along the route will ensure affected landowners and others nearby have opportunities to become educated about the project and have their questions answered.

- **Western Pennsylvania Conservancy**

\$35,000 grant to administer the Dominion Energy Watershed Mini Grants Program providing organizations with assistance to expand their capacity to administer watershed revitalization projects and publicize watershed projects in their communities. Since 2005, Dominion Energy has provided over \$370,000 in Watershed Mini Grants to more than 120 organizations.

- **Dennison Railroad Depot Museum**

Recognized as a National Historic Landmark — is the only physical structure remaining in the nation of a railroad canteen still reflecting its WWII heritage. During WWII, 1.3 million service members were served free food by 4,000 working volunteers at the Dennison Depot Salvation Army Servicemen's Canteen as they were headed to serve in Europe. Dominion Energy has provided integral support to the museum over its existence, including the donation of the VanLehn house and contents.
