Then the 100 Homes for 100 Veterans program is for you!

EnergyShare

The EnergyShare program provides bill assistance and free home weatherization to qualified Dominion Energy customers who are facing financial hardship, veterans, and individuals with disabilities. In 2018, the Grid Transformation and Security Act further expanded the EnergyShare program with a \$130 million commitment through 2028. Since 1982, EnergyShare has assisted 840,000 families. **EnergyShare** is funded by shareholders, not customers.

Dominion Energy's EnergyShare program is a partnership with the Department of Veterans Services to weatherize at least 100 homes for 100 veterans who live in the Commonwealth and are being served by Dominion Energy. Veterans who qualify will receive free energy efficiency upgrades to their homes, including insulation, LED lighting, HVAC tune-ups, and much more within the next 12 – 18 months. This means no cost to you and real savings on your energy bill. Projects may also include other home improvements related to a disability or other medical needs. The "100 Homes for 100 Veterans" project was launched on Veterans Day 2018 with the goal of completing 100 energy efficiency upgrades on 100 homes.

^{*}The Virginia Department of Housing and Community Development (DHCD) states the Virginia Median Income is \$96,804. This means that for those 60 and older, the income limit is \$116,165. For those under 60, DHCD establishes income limits based on the size of the family unit. For example, a family of four is limited to \$58,802 which is 60% of the State Median Income.
