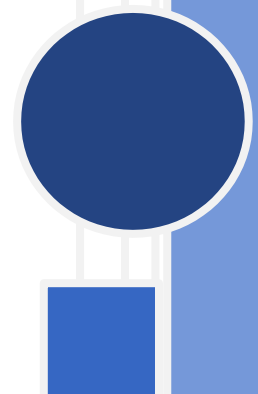

Purpose
