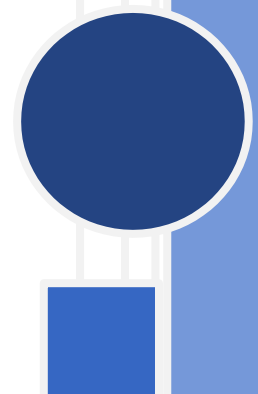

Purpose
