


# **Emergency Action Plan ANNUAL FACE-TO-FACE MEETING REPORT - 2021**

#### **Purpose**

The Emergency Action Plan (EAP) Annual Face-to-Face Meeting Report for the Possum Point Power Station Pond D (Registered Dam Inventory #153020 is produced by Virginia Electric and Power Company d/b/a Dominion Energy Virginia to comply with 40 CFR 257.105(f)(7).
