
## DOMINION ENERGY PROPOSES EXPANSION AT IDYLWOOD SUBSTATION AT SHREVE ROAD

Summer 2018 UPDATE

OUR ENERGY CHALLENGE: The existing Idylwood Substation, situated at the corner of Shreve Road and Holly Manor Drive, was originally constructed in the late 1950s. The region has experienced tremendous growth since then, and rebuilding the substation will allow Dominion Energy to provide safer, more reliable electric service to homes and businesses in Fairfax County and the cities of Falls Church and Fairfax. The enhancements will also ensure Dominion Energy complies with mandatory North American Electric Reliability Corporation (NERC) reliability standards. As an area resident, this means fewer outages and shorter durations should an outage occur.

PROJECT SCOPE: Dominion Energy plans to utilize GIS (gas-insulated substation) technology to modernize the facility. This specialized equipment is used in areas where expansion of existing equipment is limited. See the map below.

The enhanced substation will have a solid perimeter wall and new landscaping that is consistent with community aesthetics and provides sound mitigation.
