Belmont – Beaumeade 230 Kilovolt (kV) Reconductor Project: Phase 2 W&OD Trail Detour

Dear Neighbor:

At Dominion Energy, we are committed to providing the latest information to the communities we serve. You are receiving this letter to update you on the Virginia Department of Transportation (VDOT)-approved W&OD Trail detours. The detours are necessary due to wire replacement, a process known as reconductoring, on an existing 230 kV electric transmission line near your property in Loudoun County, Virginia. The reconductoring is taking place between our Belmont Substation near Gant Lane and our Ashburn Substation near Claiborne Parkway. About three miles of reconductoring are along the W&OD Trail. This work is necessary to maintain electric reliability for our customers.

The W&OD Trail will be temporarily closed between Rolling Water Terrace (near mile marker 28) and Tuscarora Creek Park (near mile marker 32) for approximately ten days in April (currently planned for Apr. 3-7 and 10-14). Dates are subject to change. The closed trail will be patrolled by law enforcement.

- An approximately 8.5-mile VDOT-approved detour with directional signage will direct trail users between Rolling Water Terrace and Tuscarora Creek Park.
- **April 3-7:** No trail crossings.
- **April 10-14:** Students who use the W&OD Trail to access Trailside Middle School and Stone Bridge High School will be permitted to cross at Trailside Park before and after school.

Through spring, there may be temporary impacts to trail users, including:

- Trail traffic may be temporarily stopped for up to 15-minute intervals
- Trail users may be directed to use either the gravel or paved paths when one is closed

This project is scheduled for completion in early June 2023.

Your electric service is not expected to be interrupted because of this project. We are committed to working safely and courteously and will restore the area once work is complete.

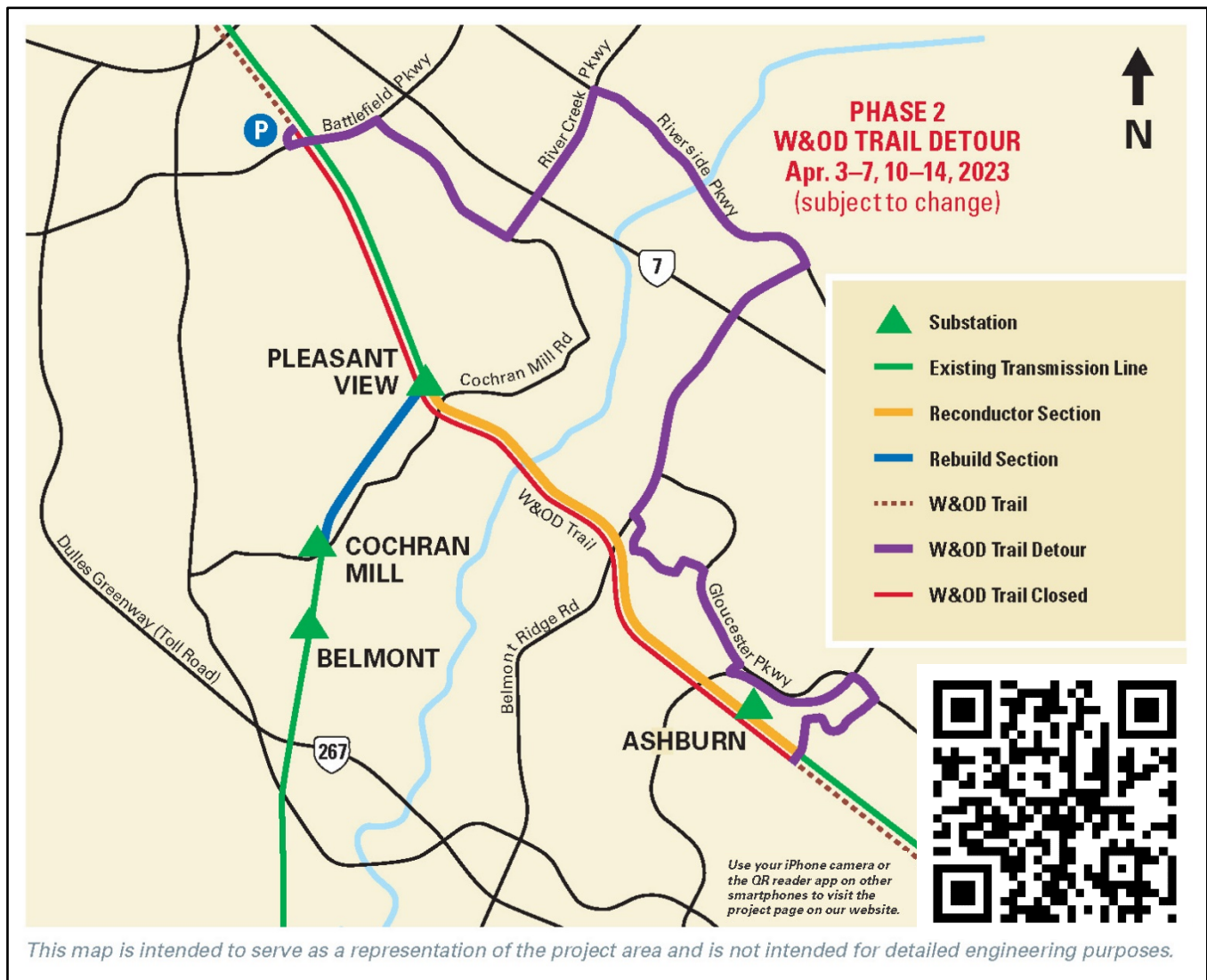

W&OD Trail Closure Apr. 3-7, 10-14

Westbound toward Leesburg

- From W&OD Trail, turn right onto detour path at Rolling Water Terrace
- Turn right on Graves Lane
- Turn right on Corder Pl
- Turn left on Deerview Dr
- Turn left on Gloucester Pkwy (Sidewalk)
- Turn left on Claiborne Pkwy
- Turn right toward Trailside Middle School, then right on Claiborne Pkwy, and left onto the paved connector trail
- Turn left on Gloucester Pkwy
- Turn left on Alexandras Grove Dr
- Turn left on Forest Farm Ln
- Turn right on Meadow Grove Dr
- Turn right on Belmont Station Dr
- Turn right on Belmont Ridge Rd
- Turn left on Riverside Pkwy
- Turn left on River Creek Pkwy
- River Creek Pkwy becomes Crosstrail Blvd at Route 7
- Turn right on Russel Branch Pkwy
- Turn left on Battlefield Pkwy
- Turn right on Solitude Ct/Kincaid Blvd and follow posted turns at Tuscarora Creek Park onto W&OD Trail, and continue west on the W&OD Trail

Eastbound toward Ashburn

- From W&OD Trail, turn right to follow posted turns to Tuscarora Creek Park
- Turn left on Solitude Ct and cross Battlefield Pkwy
- Turn left on Battlefield Pkwy
- Turn right on Russell Branch Pkwy
- Turn left on Crosstrail Blvd
- Crosstrail Blvd becomes River Creek Pkwy at Route 7
- Turn right on Riverside Pkwy
- Turn right on Belmont Ridge Rd
- Turn left on Belmont Station Dr
- Turn left on Meadow Grove Dr
- Turn left on Forest Farm Ln
- Turn right on Alexandras Grove Dr
- Turn right on Gloucester Pkwy
- Turn right on paved connector trail to Trailside Middle School, then cross Claiborne Pkwy
- At Meadow Valley Terrace, turn left to continue on Claiborne Pkwy
- Turn right on Gloucester Pkwy
- Turn right on Deerview Ln
- Turn right on Corder Pl
- Turn left on Graves Ln
- Turn left on Rolling Water Terrace and follow detour path onto W&OD Trail, and continue east on the W&OD Trail

Both paved and gravel paths will be closed and patrolled by law enforcement.
