This Request for Information (RFI) is made for informational purposes only. Responses to this RFI are not offers and cannot be accepted by Dominion Energy Virginia (the “Company” or “Dominion Energy”) to form a binding contract. This RFI is issued solely for information and planning purposes and does not constitute a solicitation for proposals. Your response to this notice will be treated as information only.

Localities, local authorities, and economic development agencies interested in participating in the Company’s pursuit of potential solar energy generation sites.

Purpose:

Dominion Energy has issued a Request for Information (RFI) to identify large-scale areas of land, greater than approximately 500 acres, on which to build and operate zero-emission solar power facilities as part of our commitment to a sustainable future for our customers and Virginia. The Commonwealth of Virginia is accelerating its transition to clean energy through the passage of the Virginia Clean Economy Act, which commits the state to achieving zero carbon emissions by 2050. This RFI is to support the company’s solar development and procurement adding approximately 15,000 megawatts of solar generation in the Commonwealth over the next 15 years.

Dominion Energy prefers locating renewable energy resources on land that is relatively flat, free of wetlands and cultural resources, and is in close proximity to the electric transmission system. Dominion Energy is reaching out to the localities for assistance in helping to identify large areas of land that landowners or counties may be interested in selling or leasing (35-year lease) in support of this effort.
