NOTICE IS HEREBY GIVEN that on April 1, 2021, Public Service Company of North Carolina, Inc. (PSNC or the Company), filed an application with the Commission in Docket No. G-5, Sub 632 requesting authority to adjust and increase its rates and charges for natural gas service in North Carolina. The Company serves approximately 600.000 retail customers in North Carolina.

On May 4, 2021, the Public Staff filed a Motion to Consolidate Dockets requesting that the Commission issue an order consolidating the Sub 632 Rate Case with Docket No. G-5, Sub 634, in which PSNC filed a request for approval to expand its existing conservation programs and to add new conservation programs. PSNC states that if the Commission approves the proposed conservation programs, their implementation is continuent upon the Commission's approval of Rider F in the Sub 632 Rate Case.

On May 18, 2021, the Commission issued an order granting the Public Staff's motion and consolidating the above-referenced dockets. The consolidated dockets are hereinafter collectively referred to as "the application."

In its general rate case application, PSNC requests authority to increase its rates and charges to produce additional overall annual North Carolina retail revenues of approximately \$53,145,476, an increase of approximately 9.3% over current revenues. Further, PSNC is seeking approval of a rate of return on common equity of 10.25%.

PSNC also seeks the following: (1) continuation of its Integrity Management Tracker rider, Rider E to the Company's approved tariffs; (2) authority to continue to defer operations and maintenance (0&M) expenses associated with its transmission and distribution integrity management programs; (3) approval of its new depreciation study; (4) authority to implement three riders to address certain liabilities arising from excess deferred income taxes (EDIT) associated with the Tax Cuts and Jobs Act and state income tax reductions; (5) approval to recover conservation program costs through deferred accounting treatment and a new rider (Rider F) mechanism; (6) approval of a new rider mechanism (Rider G) to allow PSNC to recover the costs of a

new renewable energy program to ensure proper assignment of costs to participating customers; (7) approval to fund a research and development initiative; and (8) for approval to update and revise certain tariff provisions.

The Commission has issued an order suspending the Company's proposed rate changes for a period of up to 270 days from the proposed effective date of, and setting the application for a general rate increase for hearing as follows:

The Commission has instituted an investigation into the application and has scheduled the matter for public witness hearings on, Monday August 16, 2021, to be held remotely via Webex with telephonic access. The first session will begin at 1:30 p.m. and end at the earlier of the conclusion of the last witness' testimony or 4:30 p.m. The second session will begin at 6:30 p.m. and end at the earlier of the last witness' testimony or 10:30 p.m. A link to view the hearing will be available at www.ncuc.net.

The hearings on August 16, 2021 will be solely for the purpose of receiving the testimony of public witnesses in accordance with Commission Rule R1-21(g). The Commission reserves the right to limit testimony at the public witness hearing pursuant to Commission Rule R1-21(a)(5).

Members of the public who would like to testify must register in advance of the hearing, no later than 5:00 p.m. on Monday, August 9, 2021, by contacting the Public Staff via email at PublicHearing@psncuc.nc.gov or by calling 919-733-6110. Individuals registering to testify must provide their names, topic of their testimony, the docket number (G-5, Sub 632), and the exact telephone number they will use to participate in the hearing. The telephone numbers provided will be used for witness identification; witnesses calling from any number different from the number provided to the Public Staff may be delayed or experience other difficulty in providing their testimony.

Only individuals registered with the Public Staff by 5:00 p.m. on Monday, August 9, 2021, will be allowed to testify at the hearings.

The hearing will resume in Raleigh on Monday, October 18, 2021, at 2:00 p.m., and will continue as required for testimony and cross-examination of expert witnesses for the Company, the Public Staff, and other intervenors.

For existing residential customers, an estimate of how the proposed rates (including the effects of all riders) would change the average monthly bill (including state sales tax) of a residential customer is shown below:

The change in average bill will vary with each customer's level of natural gas usage.

The Commission may consider additional or alternative rate design proposals that were not included in the Company's general rate case application and may order increases or decreases in individual rate schedules that differ from those proposed by the Company, but the Commission will not consider any increase in total revenues beyond that requested by the Company.
