NR customers with annual usage of greater than 200 Mcf and up to 500 Mcf, as determined by DEO, will default to the MRR (Monthly Retail Rate) if they don't choose a retail supplier or aggregation program, or they can elect to be placed on SCO.

NR customers with annual usage of greater than 500 Mcf, as determined by DEO, will default to the MRR (Monthly Retail Rate) if they don't choose a retail supplier or aggregation program; they are not eligible for the SCO.
