Application of Dominion Energy South Carolina, Inc. for  
Authority to Adjust and Increase its Retail Electric Rate Schedules,  
Tariffs, and Terms and Conditions

(\*This Filing Includes a Request for an Increase to  
Retail Electric Rates)

**Why is this Notice Important?**

- The Public Service Commission (“Commission”) has scheduled public hearings in this case and will decide what rates Dominion Energy South Carolina, Inc. (“DESC” or “the Company”) can charge.
- Dominion Energy South Carolina, Inc. is requesting a rate increase and changes to the Company’s electric rates and schedules for retail electric base rates.
- According to the Application, the proposed rates and charges represent an overall average increase in retail revenues of 12.6%, or approximately \$291 million, after considering the associated reduction in Demand Side Management charges that will occur when new rates go into effect.

**The Monthly impact of Dominion Energy South Carolina, Inc.’s  
new proposed rates in dollars and percentages for typical  
Company customers is as follows:**

<b>Customer Class</b>	<b>Monthly Dollar Increase</b>	<b>Average Monthly Percentage Increase</b>
<b>Residential</b>	<b>\$18.86</b>	<b>14.21%</b>
<b>Commercial</b>	<b>\$2,002.25</b>	<b>12.32%</b>
<b>Industrial</b>	<b>\$57,486.40</b>	<b>12.68%</b>

- A typical customer would be (a) a residential Rate 8 customer using 1,000 kWh per month; (b) a Rate 20 commercial customer with a 500 kVA demand using 150,000 kWh; and (c) a 10 MW Rate 23 Industrial customer with a 90% load factor.
- In separate proceedings, Dominion Energy South Carolina, Inc. is seeking to decrease its fuel component and also increase its demand side management and pension components charged to customers beginning in May of 2024. **If approved as requested, the total impact to a typical residential customer resulting from these changes and the proposed rate increase requested in this docket, would be:**
