OFFICIAL RULES

NO PURCHASE, PAYMENT, OBLIGATION OR USE OF DOMINION ENERGY SOUTH CAROLINA PRODUCTS OR SERVICES IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ENTRIES RECEIVED. THIS PROMOTION IS ONLY OPEN TO ELIGIBLE ENTRANTS AS DEFINED IN PARAGRAPH 5 BELOW. - PROGRAM PROMOTION. Dominion Energy South Carolina, Inc. ("Sponsor" or "Dominion Energy"), 220 Operation Way, Mail Code DSM, Cayce, SC 29033-3701, is offering a chance to win 1 of 3 Home Depot gift cards valued at \$250 each. The Program Promotion is not endorsed by Home Depot, and Entrant understands that he or she is providing information to Sponsor and not to any other company. THIS PROGRAM PROMOTION IS NOT SPONSORED, ADMINISTERED, ENDORSED, OR AFFILIATED IN ANY WAY WITH HOME DEPOT, OR WITH FACEBOOK, INSTAGRAM, TWITTER, OR ANY OTHER SOCIAL MEDIA PLATFORM. The Program Promotion is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
- 2. **PROGRAM PROMOTION PERIOD.** The Program Promotion starts on October 1, 2022 and closes on November 30, 2022.
- 3. **PARTICIPATION CONSTITUTES ACCEPTANCE.** By entering this Program Promotion, Entrant provides his or her full and unconditional acceptance of these Official Rules, the interpretation of these Official Rules by the Sponsor, and the decisions of the Sponsor, which are final and binding. Winning a Gift Card is contingent upon fulfilling all requirements set forth herein.
- 4. **SPONSOR RIGHTS.** Sponsor reserves the right, in its sole discretion, to disqualify any Entrant (and his/her Entry) determined to be in violation of these Rules. Sponsor's failure to enforce any term of these Rules shall not constitute a waiver of that provision. The Sponsor reserves the right, in its sole discretion, to cancel, modify, or suspend the Program Promotion if it is not capable of running as planned for any reason.
- 5. ELIGIBILITY. Entrants but must be at least eighteen (18) years old at the time of entry. Entrants must be Dominion Energy South Carolina customers, with electric service, in good standing throughout the entire Program Promotion Period and at the time of the drawing. Participation is limited to eligible customers who call or go online between October 1, 2022 and November 30, 2022 to schedule pickup. All pickups must be completed no later than December 31, 2022. Customers who call or go online to schedule their pickup before October 1, 2022 or after November 30, 2022 are not eligible to participate. The Program Promotion is not open to any Dominion Energy South Carolina account holder who has had two (2) eligible refrigerators or freezers picked up for recycling during the period beginning December 1, 2021 through September 30, 2022. Employees, officers and directors of Sponsor, and its parent companies, subsidiaries, affiliates, advertising and promotion agencies, or law firms ("Program Promotion Entities"), and the immediate family members of any such employee, officer or director, and any person residing in their same households, whether or not related, are not eligible to participate in the Program Promotion. The term "immediate family member" includes spouses, unmarried partners, grandparents, parents, siblings, children, and grandchildren, regardless of where they reside.

- 6. ENTRY. You will automatically receive one (1) entry for each free pickup of an eligible refrigerator or freezer for recycling that takes place during the Program Promotion Period. You are only allowed to have two (2) eligible refrigerators or freezers picked up for recycling by Dominion Energy South Carolina during the appliance recycling program year (December 1 through November 30). Therefore, the maximum number of potential entries into the Program Promotion you may receive is two (2), and that number may be one (1) or zero (0), depending on whether you have previously had one or more eligible refrigerators or freezers picked up for recycling in the period set above in Section 5 beginning December 1, 2021 through September 30, 2022.
- 7. **WINNER SELECTION.** The Prize winner will be randomly selected by Sponsor from all eligible entries. The drawing will be conducted on/before January 31, 2023.
- 8. NOTIFICATION AND PRESENTATION OF PRIZE. Sponsor will notify Prize winner by phone call/email to the Registered Phone Number/Email Address on Prize winner's Dominion Energy South Carolina electric account. Once contact has been made, the Gift Card will be mailed to Prize winner. If a potential winner a) cannot be contacted, b) fails to acknowledge the winning status by February 15, 2023, or c) declines the Prize, an alternate winner may be selected at Sponsor's sole discretion. The alternate winner will be notified in the same manner provided herein. If no eligible winner can be identified after reasonable attempts, Prize may not be awarded.
- 9. PUBLICITY. By entering the Program Promotion, Entrant agrees to the use by Sponsor and its designees of his or her name, city and state of residence, and photograph/likeness/voice for advertising, promotional and other purposes, worldwide and in perpetuity, in any and all forms of media, now known or hereafter devised (including and without limitation, the Internet) without additional compensation or permission, except where prohibited by law.

In any action brought to enforce the obligation or right of any party hereunder, they consent to personal jurisdiction and venue in any court of appropriate jurisdiction in Richland County, South Carolina. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
